AND WHEREAS the Lifetime Trustee Sri.S.Subramanian passed away on 21.06.2020 which has created a vacuum in the Trust. Therefore, the Managing Trustee has thought it fit to bring in new Trustees for the effective and efficient administration of the various Trust activities. Accordingly, by a Resolution passed at the meeting held on 26.08.2020, the Managing Trustee has appointed Mrs.S.Vathsala, Mrs.Reena Christy and Miss.,S.Arundathi as the new Board of Trustees along with the Managing Trustee and the other Trustee Mr.E.J.Ayyappan. However, the appointment of Mrs.S.Vathsala as one of the Trustee runs contrary to the desire of the Lifetime Trustee under the Will dated 03.02.2020, by a Resolution at its meeting held on 16.11.2020 the Board Resolved and ratified that the said Mrs.S.Vathsala is removed from the post of Trustee and communicated accordingly.

During the said Meeting it was also further Resolved that one Dr.P.Viswanathan son of Mr.Palaniswamy, residing at No.6, 11th Avenue, Seashore Town, Panaiyur, Chennai 600 119 and one Mr.V.Muthusami son of Mr.P.Velayutham, residing at "Sri Sivasailam", Aranmanai Puthur II Street, Tirupur 641 604, shall be inducted in the Board of Trustees along with the other 2 Trustees appointed earlier on 26.08.2020.

AND WHEREAS currently the Trust is represented by its Lifetime Trustee / Managing Trustee Miss.S.Aparajitha along with one Mr.E.J.Ayyappan as a Trustee besides Mrs.Reena Christy, Miss.S.Arundathi, Dr.P.Viswanathan and Mr.V.Muthusami, who have been inducted in the Board of Trustees by virtue of the Resolution dated 26.08.2020 and 16.11.2020 respectively.



AND WHEREAS the Trustees who were in the Trust as on 07.10.2014 namely Mr.A.S.Arumugam and Mr.A.Rajendran are no longer Trustees of the said Trust for the reason that the said Mr.A.Rajendran has since acted detrimental to the interest of the Trust, was duly removed by a proceedings of the Trust dated 15.11.2017 wherein it was unanimously resolved to remove Mr.A.Rajendran. The other Trustee namely Mr.A.S.Arumugam, by a letter dated 02.09.2019, has resigned from the Trust due to personal reasons which was duly accepted by the Trust in its Meeting held on 03.09.2019 and necessary Resolution in this regard were also passed.

AND WHEREAS after the death of the Lifetime Trustee Sri.S.Subramanian, the other Trustee namely Mr.E.J.Ayyappan, involved in certain activities detrimental to the interest of the Trust which resulted in a Police complaint formulated into a FIR No.2198/2020 dated 16.10.2020 in Palladam Police Station, wherein the said Mr.E.J.Ayyappan has been cited as the second accused.



Under the said circumstances, in the Meeting of the Trust held on 16.11.2020, the said Mr.E.J.Ayyappan has been removed from the Trustee of the Trust and has also been duly communicated about his removal.

[3] The Trustee shall ceased to be a Trustee in the event of the Trustees are found acting detrimental to the interest of the Trust.


